FIR POINT DOCTRINAL STATEMENT

Fir Point is an evangelical, Christian camp. Our goals are to introduce our campers to the Lord Jesus Christ so that those who do not know Him as their personal Savior will be given an opportunity to place their trust in Him, and so that those who do know Him as Savior might be equipped and encouraged to grow in Him and serve Him. For these reasons, it is of the utmost importance that you be in agreement with the Doctrinal Statement of Fir Point Bible Camp. Please read the following statement carefully. FIR POINT BIBLE CAMP DOCTRINAL STATEMENT AND CONSIDERATIONS

Fir Point Bible Camp is built upon the Word of God and our personal faith in Jesus Christ. We hold to the great foundational truths of the historic Christian faith held in common by like-minded evangelical Christians with whom we share both fellowship and the mission mandate:

We believe that there is one God, Creator, and Sustainer of the universe, existing in three persons: Father, Son, and Holy Spirit.

We believe that the Bible is the verbally inspired Word of God, is inerrant in the original manuscripts, and is uniquely infallible, being our only authority for faith and practice.

We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His substitutionary sacrifice upon the cross, in His bodily resurrection, in His victory over sin and His enemy Satan, in His present exaltation at His Father's right hand, and in His personal return, at any time, in power and great glory.

We believe in the fall and the lost condition of man, whose total depravity requires that he be regenerated by the Holy Spirit for his salvation.

We believe that salvation consists of the forgiveness of sins, the imputation of Christ's righteousness, and the gift of eternal life, received by grace through faith alone, entirely apart from works.

We believe in the ministry of the Holy Spirit, by whose indwelling the Christian is enabled to live a godly life, and by whom the Church, the Body of Christ, is gifted and equipped to serve and glorify God.

We believe in the bodily resurrection of all mankind: those who have trusted in Christ, the ultimate Judge, will receive everlasting life and blessedness in heaven; those who have not will receive everlasting punishment and separation from the presence of God.

We believe that Christ has commanded His Church to preach the gospel to all people, and that this mandate should be a primary concern of all Christians.

CONSIDERATIONS

Fir Point Bible Conference, of which Fir Point Bible Camp is a ministry, has historically affirmed the biblical doctrines of eternal security, personal holiness and the cessation of the sign gifts of the early church period. We recognize that evangelical Christians may hold differing views of spiritual gifts, eternal security, end-time events and other matters that, in love, we can agree to disagree on. In keeping with the Conference position, however, we would ask you not to teach views contrary to those held by the camp while onsite and engaged in ministry to our campers. Camp staff who do not honor this request may be dismissed.

From time-to-time different popular movements crop up in the church, sometimes advocating a departure in some sense and/or degree from a complete and coherent understanding of biblical teachings. Should it be deemed necessary, the InFaith missionary(ies) involved with Fir Point Bible Camp will investigate the movement(s) in question and make a judgment on whether or not the teaching is consistent with sound biblical teaching. If, in the missionary's(ies) assessment, the teachings of a given movement are found to be false or otherwise detrimental to sound biblical teaching, the promotion of that movement's beliefs will not be allowed by any camp staff while onsite and engaged in ministry to our campers. Camp staff who do not honor this decision may be dismissed.

Fir Point Bible Conference and Camp affirm a biblical view of appropriate sexual relationships—that is, between a husband and wife. All other expressions, including homosexuality, sex outside of marriage, the viewing of pornography and sexually inappropriate conduct towards others is sinful and will not be tolerated. Camp staff engaging in or promoting sinful expressions of sexuality will be dismissed.

The use of drugs, alcohol or tobacco by camp staff is strictly prohibited and will result in immediate dismissal. Camp staff may also be dismissed for behavior deemed inappropriate, immoral or detrimental to the camp.

Camp staff who are accused of misconduct have the right to ask the Camp Board to weigh the evidence and render a judgment on the validity of their conduct and to determine whether the staff member should be disciplined or dismissed. The decision of the Camp Board is final.

I am in agreement with the doctrinal statement and biblical and moral considerations of Fir Point Bible Camp and agree to abide by them.
